



Dear Commercial Vendor,

Barnstable County Fair is Cape Cod's own Fair, a family tradition for 175 years. There are animal shows, 4H demonstrations, horticulture displays, rides and games, live music, arts and crafts, food and commercial vendors with various products for sale. The **2019 Fair dates** are Monday, July 22 thru Sunday, July 28, which is 7 days. **Daily hours:** Monday thru Thursday: 4:00 PM – 10:00 PM, Friday thru Saturday 12:00 PM (Noon) – 10:00 PM, and Sunday 12:00 PM – 9:00 PM. Admission gates close at 10:00 PM and Rockwell midway area is open until 11:00 PM Monday – Saturday; on Sunday, gates close at 9:00 PM and midway is open until 10:00 PM.

**Commercial Non-Food Vendors** will be located inside the Marketplace Building or designated outside areas. The spaces are divided into 10' x 10' blocks. These spaces are arranged so that there are convenient walkways. Pricing for a 10' x 10' space inside **starts** at \$550 and up. Pricing for outside **starts** at \$800.00 and up.

**Commercial Food Vendors** are located throughout the Fairgrounds, and cost will vary according to the space required. Pricing **starts** at \$800.00 and up.

Additional charges at the Barnstable County Fair include: a mandatory electricity charge, a tent charge (if applied), and an insurance charge (if wanting insurance through us for your business). These charges are based upon current rates given by the electric, tent and insurance companies.

There is also an additional cleaning deposit of \$100.00 required on all contracts. This deposit is used to protect the Fairgrounds. Upon leaving the Fairgrounds on July 28, 2019, if your rented area was not damaged and is cleaned thoroughly, the cleaning deposit will be returned to you in August. However, the cleaning deposit **will not** be returned if the Fairground has to clean or repair damages caused by your company.

Would you consider becoming a part of our Fair family and renting a space? Consider this – we are anticipating over 80,000 visitors during the 7 day run of the Fair. Many are local year round residents, some are yearly summer residents and the majority are tourists. Where else can you get exposure like this on Cape Cod for your products and/or services?

OTHER:

- BCAS charges a **\$100.00 cleaning fee** for commercial space. This cleaning fee will be refunded in August if the space you rented is cleaned and without damages.
- BCAS **REQUIRES** that licensee shall maintain **PUBLIC LIABILITY AND PRODUCTS LIABILITY INSURANCE** of not less than **\$1,000,000**. **AND PROPERTY DAMAGE** of not less **\$1,000,000**. per accident. **APPROPRIATE CERTIFICATES OF INSURANCE ARE REQUIRED.** BCAS can provide insurance for your business at a cost of \$150.00. Please note if you want insurance: Yes or NO. NOTE: Insurance prices are subject to change without notice.

**\*\*\*COST OF SPACE PER RUNNING FOOT:**

- A. **INSIDE MARKETPLACE BUILDING:** Prices start at \$550.00 for a 10’ x 10’ space. An additional charge is added for corner and/or side selling footage. Space inside is located in a large building on asphalt.
- B. **OUTSIDE:** 10’ depth = \$ 80.00; 15’ depth = \$ 85.00; 20’ depth = \$ 95.00 Prices start at \$800.00 for 10’ x 10’ space. Example: 20 frontage by 20 depth (depth x frontage). You would use \$95.00 (depth) and multiply by 20 (frontage) = \$1900.00 for space ONLY. Additional charge is added for corner and/or side selling footage. Spaces outside are located in assigned grass areas.
